COMPASSION FOR STRUGGLING PATIENTS

Foundation funds needs of NICU patients and families

More than 6,000 babies are delivered annually at Ascension Saint Thomas Midtown—more than any other hospital in Tennessee. While only six to eight percent of these tiny patients are admitted to the NICU, they are vulnerable and have substantial needs.



Working directly with our Labor and Delivery service line and the NICU, the Foundation raised money on GivingTuesday to support the needs of NICU patients without financial resources, purchase developmental items for the newborns, provide additional training and learning opportunities for the care team and expand new technology and programming for clinical care. Through crocheted Octopals, Zaky HUGs, NICU journals, lodging at the Inn at Saint Thomas and educational opportunities for nurses, Ascension Saint Thomas Foundation donors helped make a difference for these tiniest patients in need.



Continuing education grants for our NICU care team

The Foundation funded 20 Beaman NICU nurses to receive Small Baby Care Specialist training through our continuing education grant program. The participants shared that they learned so much about caring for these tiny babies and how the smallest of changes in their care makes a tremendous difference in their future and quality of life. It is a unique and important task to care for this population, and the Foundation is pleased to support our nurses with opportunities to receive the expert training and knowledge they need.

Grants for patients in need

Families from across the region travel to Ascension Saint Thomas, particularly when Level III NICU expertise is needed. The Foundation provides grants for affordable accommodations or transportation assistance to parents, who have little or no resources, allowing them to spend more time with their newborns as they develop.



Grants to support bonding and developmental needs

Funding from the Foundation provides grants for the purchase of developmental items such as sound machines, mobiles, crocheted calming aids and Zaky HUG positioners.

COMMITMENT TO SUPERB PATIENT CARE

\$1.7 million invested in Holy Family Health Center renovation

With generous donor support, the Foundation invested \$1.7 million for the renovation and expansion of the Holy Family Health Center in South Nashville.

The Ascension Saint Thomas mission is to provide healthcare to all, regardless of race, ethnicity or socioeconomic status. The Holy Family Health Center is strategically located to provide quality healthcare to some of the most vulnerable and at-risk populations.

The clinic ministers to a diverse patient base from 36 countries. In addition to primary and behavioral healthcare, the Holy Family Clinic is an anchor of prenatal and obstetrical care for Hispanic women. More than half of the patients are uninsured or low-income, with an annual average income of \$30,000 or less. Everyone is welcome at the health center regardless of ability to pay.

Clinic square footage increased following renovation from 9,600 feet to almost 15,000 feet.

Dedicated OB/GYN clinical expansion with the addition of ultrasound.


Nine new exam rooms with equipment.

Expanded lab space for a second phlebotomist.

Enhanced operational workflow for additional services, such as behavioral health, dietetics and medication management/diabetes support.

Multiple medical equipment upgrades, including new vital sign machines, EKG machine, vaccine refrigerator, gel warmers and dopplers.

A productivity enhancing work space for providers with IT enhancements.



Construction of the Holy Family Clinic began in late 2020, with the clinic reopening in February 2021. A rededication was led by Bishop Spalding and Father John Raphael on June 9, 2021, where the clinic, patients and caregivers were blessed. Leading contributor Richard Speer of the Speer Foundation was in attendance.

COMMITMENT TO SUPERB PATIENT CARE

Philanthropy provides expansion of Our Mission in Motion

As the only faith-based nonprofit healthcare system in Middle Tennessee, our ministry is called to actively seek those who lack access to quality, affordable healthcare. As the only mobile mammography coach of its kind in Middle Tennessee, Ascension Saint Thomas delivers life-saving mammograms to women who might otherwise lack access to this vital exam. The crucial access to screening and breast health education provided by our mobile mammography program contributes to early detection and a reduction in late stage breast cancer and breast cancer mortality.

Over 3,000 women have been screened each year with a single coach. Since the first coach was purchased in 2011, over 23,000 screenings in 26 counties in the Middle Tennessee area have been performed.

Each year, the mobile mammography program receives more requests for service. Ascension Saint Thomas continues to

seek ways to increase the availability and affordability of breast health services to underserved, uninsured, low-income and minority women.

The Ascension Saint Thomas Foundation, in a collaborative effort with the Ascension Saint Thomas Rutherford Foundation, invested \$1,500,000 in capital improvements for the program. A second coach, equipped with 3D tomography screening, was added to our fleet in October of 2021. The existing coach is receiving a full restoration including 3D screening equipment. Both coaches will provide the same standard of care as the Ascension Saint Thomas West and Midtown Centers for Breast Health.

In 2021, the Foundation, with the help of valuable funders, invested \$57,715 to underwrite free mammograms for those who otherwise would not have been able to afford this essential service.

Ascension Saint Thomas Foundation responds to tragedy

On August 21, 2021, Waverly, Tennessee was pummeled with more than 17 inches of rain, causing a devastating flood that destroyed everything in its path and tragically claimed the lives of 20 people. The flood took out roads, cellphone towers and telephone lines, and demolished businesses and houses throughout the community. Several Ascension Saint Thomas associates were impacted by the flood.

Through the generosity of those who contribute to the Foundation's associate hardship funds, Ascension employees, including some of our newest team members at Three Rivers Hospital, were awarded expedited grants to address immediate needs created by the flood. Charitable support, made possible by donors, gave our associates hope, and helped them to begin the process of rebuilding their lives.

Amanda Maples, Business Development Director for our Ascension cardiovascular program and a lifelong resident of Waverly was one of the associates affected by the flood.

Residents of Waverly received early morning weather alerts that the area was under a flash flood warning. Though these types of warnings were not unusual, Amanda was notified by a city police officer to prepare "just in case." Amanda sped up her preparations. However, moments later, she found herself trapped with water rushing into her home.

Seven minutes later, she again spoke to the police officer. He told her that she needed to get up on the roof. Reassuringly, he also told her that her 18-year-old son was safe with him at the end of the road. She also knew that



her 16-year-old son was staying with a family friend and out of harm's way.

Furniture, mud and debris rushed through the hallway as Amanda tried to push her way to the attic ladder. The electricity was still on, which caused her to get "popped" several times as she made her way up the ladder and into the attic. At this point, she

thought she had lost her animals because she wasn't able to grab hold of them as she went up the ladder.

Once in the attic, she was able to see next door to her parents' home. She called and found that her mother was trapped in her house, which was now almost completely under water.

Amanda flagged the people on jet skis who were helping their neighbors to safety and explained that her mom was trapped in her house. After several tense moments, they were able to rescue her—right before a wall of her house gave out. They quickly returned for Amanda. The rescuers saved 15 people in the neighborhood from being washed away that day.

Hours later, Amanda and her family returned to their home to find walls missing and all of their possessions and mementos completely destroyed.

"I cannot begin to describe that experience. We didn't know where we were going to go. Our clothes were soaked with mud. All we had was what we had on," Amanda said.

The days following were filled with many questions. "Before we were able to gain back cell phone service, I had been contacted by so many people with the ministry and had the support to know that we would be okay. That support gave us what we needed to start the healing process," she said.

While they are still grieving their home and treasured possessions, they are grateful for their lives.

"The healing that the Ascension Saint Thomas community has provided goes beyond any I could ever describe. The loving energy, patience, kindness, compassion and selflessness that everyone has shown makes me so proud to be a part of this ministry."

JaMarcus never had the opportunity to meet Gary, but said that he was honored to receive the scholarship and carry on the legacy.


Each year the Ascension Saint Thomas Foundation provides financial assistance to deserving Ascension Saint Thomas associates who want to continue their education.


